TRAVELLING WELL WITH LEASECARE

If the new Ford or Lincoln vehicle you're buying or leasing needs service on a component covered by the Basic Coverage under the New Vehicle Limited Warranty or the extended component coverage, you're travelling well with immediate rental service coverage available from LeaseCARE.

Plus, depending on the coverage you choose, LeaseCARE also gives you the peace of mind protection of PremiumCARE component coverage after the expiration of your New Vehicle Basic Warranty.

ENJOY THE CONVENIENCE

ELIGIBILITY

Available for purchase on Ford vehicles within the 3 year/60,000 kilometre (whichever occurs first) New Vehicle Basic Warranty (4 year/80,000 kilometre, whichever occurs first, for Lincoln vehicles).*

NO DEDUCTIBLE

LeaseCARE comes with a \$0 deductible.

EXTENDED COMPONENT COVERAGE

The 3 year/75,000 kilometre, 4 year/80,000 kilometre and 4 year/100,000 kilometre plans include PremiumCARE component coverage after the expiration of your New Vehicle Basic Warranty. With the extended component coverage of PremiumCARE, you can travel with confidence knowing that your vehicle has the most comprehensive ESP coverage. PremiumCARE covers 500+ components, including many high-tech parts, as well as wear-and-tear failures of covered components! Plus, these plans also include additional Roadside Assistance services for the duration of your PremiumCARE component coverage. For details about ESP Roadside Assistance, please see your Dealer.

RENTAL VEHICLE REIMBURSEMENT

Includes immediate first-day coverage up to \$35/day for up to 3 days for repairs covered by the Basic Coverage under the New Vehicle Limited Warranty and extended component coverage. This benefit will also be available for Ford Recalls or Customer Satisfaction Programs involving an ESP covered component for Ford, Lincoln or Mercury vehicles only.

OPTIONAL RENTAL PLUS! VEHICLE REIMBURSEMENT

If purchased, Rental Plus! includes immediate first-day rental coverage up to \$75/day for up to 3 days for repairs covered by the Basic Coverage under the New Vehicle Limited Warranty and extended component coverage. This benefit will also be available for Ford Recalls or Customer Satisfaction Programs involving an ESP-covered component for Ford, Lincoln or Mercury vehicles only.

BACKED BY FORD

Most importantly, Ford ESP is backed by Ford Motor Company of Canada, Limited and honoured at more than 4,500 authorized Ford, Ford Lincoln and Mercury Dealers in Canada and the United States.

* Warranty begins on the original retail delivery date or on the date of first use (whichever occurs first). See your Dealer for details of this limited warranty.

TRANSFERABLE

If you buy out your lease or sell your vehicle, the remaining coverage may be transferred to a new owner. This can add to the resale value of the vehicle.

FINANCING

May be included in your lease or finance contract in most cases.

SOME POINTS TO REMEMBER ABOUT YOUR LEASECARE PLAN...

- LeaseCARE service can be obtained at more than 4,500 authorized Ford, Ford Lincoln and Mercury Dealers in Canada and the United States. Ideal if you need a rental vehicle while repairs covered by the Basic Coverage under the New Vehicle Limited Warranty or LeaseCARE are being performed.
- LeaseCARE can be purchased on its own or combined with the Ford Maintenance Protection Plan (FMPP) for Ford vehicles only or the Lincoln Maintenance Protection Plan (LMPP) for Lincoln vehicles only;[§] when LeaseCARE and FMPP or LMPP are purchased together, LeaseCARE provides rental reimbursement for repairs covered by the New Vehicle Limited Warranty or your extended component coverage, and FMPP or LMPP provides scheduled maintenance and coverage of certain wear items only – a true “gas-and-go” approach to driving costs.
- Time and distance travelled limitations for Ford ESP New Vehicle Plans are calculated from zero kilometres and the warranty start date (whichever occurs first). Ford ESP New Vehicle Plans are effective concurrent with the New Vehicle Basic Warranty and are not extensions of the New Vehicle Basic Warranty.
- Ford ESP Plan prices and component coverage are subject to the pricing and component coverage in effect at the time the plan is purchased. Plans and prices are subject to change without notice. See your participating Dealer for details. ESP Plans are subject to GST, PST and HST, where applicable.
